## Materials Needed

The CRP exam will be offered at hundreds of designated testing centers worldwide AND via live, online proctoring (you can take the exam at home!) from 16 May 2024 –9 June 2024 (the specific site, date, and time will be chosen by each registered candidate closer to the exam start date).

- Registration begins January 18, 2024.
- On or before 18 March 2024: \$350 application fee.
- Between 19 March and 12 April 2024: \$475 application fee.
- On/after 13 April 2024: \$575 application fee.
